





forts and multiply our own gifts today, just as He did that day, making our individual sacrifice an abundance.


Stewardship Is...


ministries!

Starting in the Old Testament with a 10-percent tithe to the temple, the concept is that by offering a percent of God's blessings back to His church, each family will not be offering an

equal amount, but each will be making an equal sacrifice. And so when considering how much to give in support of the church, begin by thinking in terms of percentgiving, rather than a specific dollar amount.

There are no church membership dues, and we do not publish a dollar amount that all parishioners are expected to contribute. We do however, lay the entire process on your conscience to prayerfully consider what to give. C.S. Lewis once wrote, "I do not believe one can settle how much we ought to give. I am afraid the only safe rule is to give more than we can spare." He offers a different perspective, perhaps, but right in line with sacrificial giving rather than giving without any thought at all. As, Mother Teresa once said, "If you give what you do not need, it isn't giving."

Let's lose the idea that we'll give significantly to the Church when we win the lottery! Those odds are a bit lopsided. Christian giving does not come from our abundance or from hopedfor (prayed-for?) winnings. An unknown author offered this bit of humorous poetry,

"It's not what you do with the million if fortune should

'ere be your lot, but what are you doing at present with the dollar and quarter you got."


We should also remember that stewardship giving means also giving of time and talents to church ministries. We remember specifically the example of the patron Saints of the Ladies Philoptochos Society, Cosmas and Damian, brothers and physicians who, in remembrance of the charge of Christ to his disciples, "As you go, preach this message: 'The kingdom of heaven is near.' Heal the sick, raise the dead, cleanse those who have leprosy, drive out demons. Freely you have received, freely give," and they charged nothing for their medical services.

Every family in our parish should think how they can contribute to parish ministries. Do you have the call to serve our young people, to visit or offer assistance to the sick or shut-ins, help with liturgical needs such as singing or reading, prepare the offering bread (prosfora), memorial wheat (koliva) or church flowers, greet new members, help teach current members, assist with building maintenance, or offer to begin a new ministry? How is God calling you to serve in your church? Your response

to this call is the foundation of Christian stewardship.

In summarizing the meaning and purpose of the Church, Metropolitan Maximos of Pittsburgh writes, "The Church is the great sacrament of salvation that Christ has instituted in the world. It is the Ark of salvation, and the inaugurated Kingdom of

God... The Church thus conceived is not just another human organization; it is a gathering of people who profoundly share the life of faith, the new life in Christ, the life in the Holy Spirit, the



This month we introduce all of you to two books that should be on all of your bookshelves:


Introducing the Orthodox Church:

Erato Black Barkas Foundation

As many parishioners know, Erato Barkas left all the assets of her Trust to the St. Haralambos Building Fund. Based on her wishes a Foundation was established earmarking the funds to be used to build a new church.

"The total funds of \$530,000 were transferred to the Foundation and these funds have been invested and are now earning interest. Thanks to Erato's generosity we now have a magnificent start toward building our new St. Haralambos Church."

It should be noted and Mr. Ayan would like it to be known to parishioners, that in his capacity as executor and trustee of Erato's Estate, he has not received fees or compensation of any kind for his work.

"I was hungry and you gave me food. I was thirsty and you gave me drink, I was a stranger and you took me in." (St. Matthew 25:35)

Our Lord teaches us to see and respond to those who are in need and who may be less fortunate than us. With this in mind, early this year, our Parish undertook

the challenge of joining with three other Peoria Christian communities in the Habitat for Humanity Coalition to build a new home in Peoria.

This Parish project involved two components. First, beginning in the early spring a small but dedicated group of our parishioners (Katrina Anderson, Roy Christian, Stephanie and Christine Danos, Dennis Georgen, Nick Pappas, Melanie Perrault and George and Rachel Retsinas) labored to frame up the home. By late summer the Aguillar family home was finished and it was dedicated last month on Saturday, Oct. 7.

The second component of the project involved a financial commitment to help raise the money needed by Habitat for Humanity to make the project a reality. Each church community was asked to contribute \$15,000.

Now some might ask why we, as a Parish, would agree to this arrangement while we are planning to build a new church. It's really quite simple. Aside from the Christian community outreach opportunity, this money can be raised without negatively impacting our ability to fundraise for our own building project.

The State of Arizona allows for a dollar for dollar tax CREDIT on your Arizona state income tax when making contributions to certain charitable organizations. Habitat for Humanity qualifies for this special tax treatment.

What's the difference between a charitable tax credit and a charitable deduction that you itemize? A charitable tax credit is much more favorable to you. A charitable tax credit reduces your Arizona tax liability dollar for dollar. In other words, it gives to your favorite qualified charity what you

would otherwise pay to the State in income tax. Charitable deductions on the other hand, such as we make to the Church, are itemized and subtracted from gross income to determine the amount of our taxable income.

Here's how a charitable tax credit compares to an itemized deduction.

Gross Income	\$50,000	Gross Income	\$50,000
Itemized Deductions	10,000	Itemized Deductions	9,600
Net Income	40,000 (taxable)	Net Income	40,400

Note: If you itemize, the charitable tax credit is also deductible on your Federal return thus also reducing your US income tax.

Even if you do not owe any Arizona state taxes at the end of the year, if you withheld any amount larger than your tax liability, your charitable tax credit will result in a larger income tax refund from the State.

The maximum allowable contribution for the charitable tax credit is \$400, and the contribution must be made in the current calendar year (2006) to qualify for the charitable tax credit that year. Consult your tax advisor for complete details.

The calendar year is coming to a close and the time to make your 2006 contribution is running out. When making your contribution, please complete and mail the form below, directly to Habitat for Humanity. You will receive an acknowledgement from Habitat for the contribution to use when filing your taxes.

We thank our volunteers for their labor of love, and encourage all parishioners to offer whatever financial gift they are able to make in support of our Habitat for Humanity project.
